Destiny Training Systems LLC Policies

Live Event/ Seminars Refund, Transfer and Guarantee Policies:

Refunds and Transfers:

Because of the extensive planning and allocation of resources required to facilitate a Destiny Training Systems, LLC event, as well as our revenue agreements with joint venture partners, it is our policy to only issue tuition refunds as follows:

When you register for a seminar you have 10 days from the date of enrollment to make a cancellation or request a transfer to a different program date without being charged a transfer fee (loss of revenue), unless your enrollment occurs 0 - 14 days prior to the event, in which case, no refund or transfer will be issued. No refunds will be issued after 10 days from the date of enrollment. Requests for cancellations or transfers at that point will result in a loss of revenue for Destiny Training Systems, LLC. Because of the limited number of preview engagements we offer for event registration, as well as the limited number of seats in each seminar, we also lose the ability to fill your seat and the revenue of potentially selling the new seat. This policy will be strictly enforced and your cooperation is greatly appreciated. Any refunds approved will be delivered by the same method in which payment was received.

Our Cancellation/ Transfer policy offers the following options:

After 10 days, you may transfer* to a different program date for a transfer fee of \$200 per person attending, unless the request for transfer occurs 15 - 30 days prior to the seminar, in which case, a transfer fee 50% of paid tuition will be assessed. If the request to transfer occurs 0-14 days prior to the seminar, no transfer credit will be issued & tuition will be forfeited.

If for any reason the registered client(s) cannot attend the seminar, they may find someone else to attend in their place and must submit written notification of that person's name and contact information to Destiny Training Systems, LLC prior to the seminar.

If any products are received in conjunction with the offer, they must first be returned in new, unused condition in order for any refund or credit to be processed. (Shipping and handling costs are not refundable.) Any approved refunds will be issued within 30 days of Destiny Training Systems, LLC's receipt of the returned products (if required).

All cancellations must be made in writing and delivered by mail (631 N. Stephanie St. # 376, Henderson, NV 89014), faxed to 503-961-9817 or emailed to info@destinytraining.com. Voicemail and verbal correspondence do not constitute written cancellation notice. Cancellation notice will be deemed to be the date on which Destiny Training Systems, LLC receives the written notification, not the date upon which it was written.

Should the client fail to notify Destiny Training Systems, LLC in writing of any changes and not "attend" the event, there will be **no refunds, credits or transfers** available.

**Course transfer credits are valid for 1 year from the date of cancellation, regardless of whether the course originally registered for is offered again within this time period. Transfer credits can be used towards a different program if it takes place prior to expiration of your transfer credits should the program you originally registered for be discontinued or is not offered again in that time period. All dates and locations are subject to change without notice.

All pricing on courses is for "tuition" only. All food, travel and accommodations are not included in the event price unless specifically stated in writing by Destiny Training Systems, LLC.

The client agrees that Destiny Training Systems, LLC and/or their representatives are not responsible for any applicant's travel, hotel, meals or other related expenses, regardless of confirmation or cancellation of any event.
